




# **Curaçao:** For Real Estate

# Curação Advantages

Residence by Investment Program (Investors Permit)

#### **Overview**

The government of Curaçao now allows foreign investors through its Residence by Investment Program (Investors Permit) special access to invest and live in Curaçao for an extended period.

Investors can provide a real economic benefit to Curaçao. To facilitate the stay of high-net-worth investors who wish to reside in Curaçao for a period of more than 6 months per year, the Government of Curaçao has issued the Guidelines Investors Permit 2014.

The goal of the Guidelines Investors Permit is to facilitate investment in Curaçao (among others, purchase of real property or making a business investment) by high-net-worth foreigners, thus contributing to our economy.

#### Requirements

To qualify for the temporary permit as a "high net worth investor" you must meet the following requirements:

- Present official documents that you have made or intend to make a business investment of at least ANG 500.000.
- Having sufficient financial resources at your disposal to meet the obligations arising from the investment.
- A private health insurance policy.

#### **CONDITIONS**

The first permit will be issued for a period of one or more years, depending on the amount of the investment. Subsequent permits will be issued for similar periods if the requirements for the residence permit are met.

- With an investment of at least **ANG 500.000 (US\$ 281,000),** you may qualify for a residence permit for a period of **3 years** which will be renewed if the circumstances remain unchanged.
- With an investment of at least **ANG 750.000 (US\$ 420,000),** you may qualify for a residence permit for a period of **5 years** which will be renewed if the circumstances remain unchanged.

#### Permit for an indefinite period

With an investment of at least **ANG 1.500.000 (US\$ 838,000),** you may qualify for a residence permit for an indefinite period. In that case, your permit does not need to be renewed. However, you will still need to be able to have sufficient financial resources at your disposal and have a private health insurance policy.

#### **Services**

The promotion and facilitation of investment activities include:


